**RESOLUTION APPROVING ANNOUNCEMENT OF  
SOLICITATION OF APPLICANTS FOR PAID POSITION  
OF FIRE DISTRICT CHIEF**

**WHEREAS**, the current Chief of Hanover Township Fire District No. 3 has announced his intention to retire from his position effective April 1, 2015, following long and meritorious service with the District; and

**WHEREAS**, the Board of Fire Commissioners of Hanover Township Fire District No. 3 seeks to identify a candidate to replace the retiring Chief, giving preference to qualified current paid and volunteer members of the District's firefighting force, and to assure that the best available and qualified candidate is selected to assume the duties of Chief; and

**WHEREAS**, the Board of Fire Commissioners desires to provide for a transition period under which the selected candidate can work closely with the current Chief, prior to the current Chief's retirement, to assure an efficient transition of authority and continuity in District operations; and

**WHEREAS**, the Board of Fire Commissioners desires to adopt the Announcement of Solicitation of Applicants for Paid Position of Fire District Chief attached hereto, and to adopt the terms for the position of Chief of Hanover Township Fire District No. 3 as set forth therein in accordance with *N.J.S.A. 40A:14-81.1*.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT NO. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY, as follows:**

1. The Announcement of Solicitation of Applicants for Paid Position of Fire District Chief, attached hereto, and the terms set forth therein, are hereby adopted, determined and established by the Board of Fire Commissioners.
2. That this Resolution shall be introduced and passed after a first reading, by title, and thereafter published in full at least once in a newspaper having substantial circulation in the Fire District, together with a notice of the introduction and notice that this Resolution will be considered for final passage at the next regularly-scheduled meeting of the Board of Fire Commissioners.
3. That this Resolution be so published, and also posted in such public places as notices are usually posted in the District, for a period of at least one week prior to the next regularly-scheduled meeting of the Board of Fire Commissioners.
4. That copies of this Resolution be made available to each person so requesting a copy.
5. That this Resolution be given a second reading by title at the next regularly-scheduled meeting of the Board of Fire Commissioners, and that prior to final approval, a hearing be conducted during which all interested persons shall be given an opportunity to be heard.
6. That upon final adoption after a second reading, this Resolution shall be published by title at least once in a newspaper having substantial circulation in the Fire District, together with notice of the date of final approval.
