## **RESOLUTION APPOINTING AUDITOR**

**Resolution 13-03-05- 12**

**WHEREAS**, there exists a need for Auditing Services for the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, and


**WHEREAS**, funds are available or will be available for the purpose of obtaining such services; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A; 11-1 et seq.) requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be publicly advertised:

**NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, IN THE TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY**, as follows:

1. Vincent M. Montanino, of V. M. Associates of Mt. Arlington, NJ, is hereby appointed as auditor for this Board to serve for a term of one year or until the reorganization meeting of the Board following the annual election.
2. Said auditor shall be paid on a fee for services basis for all services rendered, except as otherwise provided in the professional services agreement between said auditor and the Commissioners.
3. This appointment is made without competitive bidding as "Professional Services" under the provisions of the Local Public Contract Law because the services to be rendered or performed are by persons authorized by law to practice a recognized profession and whose practices are regulated by law and such services are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids.
4. Notice of the authorized contract award shall be published in the official newspaper within ten (10) days of its passage.
