- 1. Man Lee, of Nisivoccia, LLP, 200 Valley Road, Suite 300, Mt. Arlington, New Jersey 07856, is hereby appointed as auditor for this Board to serve for a term of one year or until the reorganization meeting of the Board following the annual election.
- 2. Said auditor shall be paid on a fee for services basis for all services rendered, except as otherwise provided in the professional services agreement between said auditor and the Commissioners.
- 3. Notice of this award shall be published in the official newspaper and shall be made available for public inspection.
