- 1. **Stephen E. Trimboli, Esq.** of Trimboli and Prusinowski, LLC, 268 South Street, Morristown, is hereby appointed as labor counsel for this Board to serve for a term of one year or until the reorganization meeting of the Board following the annual election.
- 2. Said counsel shall be paid on a fee for services basis for all services rendered, except as otherwise provided in the professional services agreement between said auditor and the Commissioners.
- 3. Notice of this award shall be published in the official newspaper and shall be made available for public inspection.
