WHEREAS, the Fire District is desirous of hiring A Provisional Firefighter/EMT to maintain its necessary staffing levels, and

WHEREAS, the Fire District Chief has appropriated funding for this position in its 2020 Fire District Budget, and adequate funds are available, and

WHEREAS, this position was adequately posted and requested candidates from within the Fire District meeting the necessary qualifications to apply to the Fire Chief, and

WHEREAS, during this State of Emergency brought about by the COVID-19 Pandemic, the Board has found it necessary to forego the normal processes established for hiring, and

WHEREAS, hiring into this position is Provisional at this time, and a candidate's appointment to Probationary Firefighter/EMT shall subsequently be made consistent with the direction of the Board of Fire Commissioners, and

WHEREAS, the candidate listed below has been found to have met the requirements as set forth in the job announcement as posted, and has been recommended for appointment by the Fire Chief.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District No. 3 of the Township of Hanover in the County of Morris and State of New Jersey as follows:

- 1) David Sulpy is hereby appointed to serve as a Provisional Firefighter/Emergency Medical Technician effective Friday, April 3, 2020, and
- 2) David Sulpy shall be subject to the Policies and Procedures of the Fire District, and the terms and conditions as set forth under the Collective Bargaining Agreement between the Fire District and FMBA Local 109, and
- 3) David Sulpy shall receive a base salary of \$43,000.00 per year, and
- 4) David Sulpy shall be subjected to a probationary period of no less than one (1) year and does not retain any type of permanent status within the Fire District and may be dismissed at the discretion of the Board of Fire Commissioners only after proper preliminary notice has been given allowing the employee the opportunity for a hearing before the Board of Fire Commissioners.
- 5) David Sulpy shall maintain all requisite certifications commensurate with the job title
