RESOLUTION RESCINDING RESOLUTION 20-04-16-43; RESOLUTION TERMINATING VOLUNTEER FIREFIGHTER/EMT TIMOTHY FAWCETT

RESOLUTION 20-06-04-52

WHEREAS, Resolution 19-11-07-91 passed by the Board of Fire Commissioners on April 4, 2020 with the intent of terminating Volunteer Firefighter/Per Diem EMT Timothy Fawcett, and

WHEREAS, consistent with his rights as afforded by the Fire District, Volunteer Firefighter/Per Diem EMT Timothy Fawcett was heard by the Board of Fire Commissioners on May 21, 2020 in Executive Session, and

WHEREAS, the Board of Fire Commissioners acquiesce to Volunteer Firefighter/Per Diem EMT Timothy Fawcett request to rescind the termination as a Volunteer Firefighter and to accept his resignation as a Per Diem EMT from the Fire District.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF FIRE COMMISSIONERS OF FIRE DISTRICT No 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS that

- 1) Resolution 20-04-16-43 is hereby rescinded, and
- 2) Timothy Fawcett shall be reinstated to the position of Volunteer Firefighter effective May 22, 2020, and the period between the original resolution and the reinstatement shall be time served as a suspension, and
- 3) Volunteer Firefighter Timothy Fawcett shall be on probation for a period of not less than six (6) months, and
- 4) Per Diem EMT Timothy Fawcett resignation from Per Diem EMT with the Fire District shall be accepted under cover of a separate and subsequent resolution.
