- 1. Richard Braslow, Esq., 516 Fielders Lane, Toms River, New Jersey is hereby appointed as legal counsel for this Board to serve for a term of one year or until the reorganization meeting of the Board following the annual election.
- 2. Said Counsel shall be paid on a fee for services basis for all services rendered, except as otherwise provided in the professional services agreement between said auditor and the Commissioners.
- 3. Notice of this award shall be published in the official newspaper and shall be made available for public inspection.
