- 4) Nicholas DiGiacomo shall be subjected to a probationary period of no less than one (1) year and does not retain any type of permanent status within the Fire District and may be dismissed at the discretion of the Board of Fire Commissioners only after proper preliminary notice has been given allowing the employee the opportunity for a hearing before the Board of Fire Commissioners.
- 5) Nicholas DiGiacomo shall maintain all requisite certifications commensurate with the job title
