A RESOLUTION APPOINTING A PROBATIONARY FIREFIGHTER/EMERGENCY MEDICAL TECHNICIAN (EMT)

RESOLUTION 24-11-07-129

WHEREAS, the Fire District is desirous of hiring A Firefighter/EMT to maintain its necessary staffing levels, and

WHEREAS, the Fire District has sufficient funds in its 2024 Fire District Budget for this position, and

WHEREAS, this position was adequately posted and candidates whom met the necessary qualifications applied, and was tested according to the processes outlined by the District, and

WHEREAS, the candidate listed below has been found to have met all of the requirements as set forth in the job announcement as posted, as well as the Conditional Offer of Employment dated October 17, 2024, and successfully completed all required testing, and has been recommended for appointment by the Fire Chief.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District No. 3 of the Township of Hanover in the County of Morris and State of New Jersey as follows:

- 1) Michael Bergman is hereby appointed to serve as a Probationary Firefighter/Emergency Medical Technician effective Monday, November 25, 2024, and
- 2) Michael Bergman shall be subject to the Rules and Regulations and Policies and Procedures of the Fire District, and the terms and conditions as set forth under the Collective Bargaining Agreement between the Fire District and FMBA Local 109, and any Memorandum of Agreement attached thereto, and
- 3) Michael Bergman shall receive a base salary of \$50,500.00 per year, and
- 4) Michael Bergman shall be subjected to a probationary period of no less than one (1) year and does not retain any type of permanent status within the Fire District and may be dismissed at the discretion of the Board of Fire Commissioners only after proper preliminary notice has been given allowing the employee the opportunity for a hearing before the Board of Fire Commissioners.
- 5) Michael Bergman shall maintain all requisite certifications commensurate with the job title
