WHEREAS, the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, deem it necessary to provide bonding for the Commissioners, the Treasurer of the Commissioners Board, the Chief of the Fire District, all public employees under the authority of the Fire District and the Cedar Knolls Fire Department, Inc.

NOW THEREFORE, BE IT RESOLVED by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, as follows:

- 1) All Commissioners and public employees referenced above shall be bonded in the amount of One Million Five Hundred Thousand Dollars (\$1,500,000.00)
- 2) The Cedar Knolls Fire Department, Inc. referenced above shall be bonded in the amount of Five Hundred Thousand Dollars (\$500,000.00)
