- 2. The Fire District shall operate under existing administrative guidance and policy until such time as a new resolution establishing minimum staffing levels is duly adopted.
- 3. The Chief is directed to review current staffing demands and provide recommendations to the Board for any future resolution establishing or amending minimum staffing requirements.
- 4. This resolution shall take effect immediately upon adoption.
