WHEREAS, there exists a need by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, N.J., for compensated Emergency Medical Technicians to respond to emergency scenes as well as other needs of the District; and

WHEREAS, the Board of Fire Commissioners has levels of employment as compensated Emergency Medical Technicians including Full-Time, Part-Time and Per Diem, and

WHEREAS, the Board of Fire Commissioners has job descriptions for each of these positions as well as terms and conditions of employment, and

WHEREAS, EMT Catherine Atwood is currently employed in the position of Per-Diem Emergency Medical Technician, and has applied for their job title and responsibilities to be changed to Part-Time Emergency Medical Technician.

NOW THEREFORE, BE IT RESOLVED by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, N.J., as follows:

1. EMT Catherine Atwood shall assume the duties, scheduling and responsibilities of the position of Part-Time EMT effective July 7, 2025, and
2. EMT Catherine Atwood shall be subject all policies procedures, terms and conditions of employment as established by the Fire District for the position of Part-Time EMT, and
3. EMT Catherine Atwood shall be subject to a probationary period of not less than six (6) months from the date of this appointment.
