WHEREAS, driver's license records are maintained by the New Jersey Motor Vehicle Commission, who maintain a portal for the purposes of organizations to access said records, and

WHEREAS, the Fire District has made application, and has been approved access to these records, which necessitates the execution of a Memorandum of Understanding enumerating the provisions of such access.

**NOW THEREFORE BE IT RESOLVED** by the Board of Fire Commissioners of Fire District No. 3, Township of Hanover, County of Morris that:

- 1) The Administrator of the Fire District is hereby authorized to enter into the aforementioned Memorandum of Agreement, attached hereto, and
- 2) All access to driver's license records shall be consistent with the Policies and Procedures of the Fire District, and N.J.S.A. 39:2-3.4(b), and
- 3) All records derived from any transaction shall be maintained in accordance with the Policies and Procedures established by the Fire District.
