WHEREAS, the District finds this practice to be desirable and in the interest of public safety, and is done so under the provisions of our Policies and Procedures, and

WHEREAS, consistent with the provisions of N.J.S.A. 40A:14-118, Hanover Township Police Department is a recognized law enforcement agency in the State of New Jersey, and has the ability to perform such criminal background investigations through State and National databases, and

WHEREAS, the Memorandum of Agreement attached hereto, formally attached hereto engages the Hanover Township Police Department for the providing of such services for the period enumerated therein.

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY as follows:

1. The Chairman of the Board of Fire Commissioners, or his/her designee is authorized to sign and execute the attached Memorandum of Agreement, between Fire District No. 3 and the Hanover Township Police Department for the providing of criminal background investigations, and
2. The Fire District shall provide all documentation as required by the Hanover Township Police Department to facilitate this goal..
