#### **RESOLUTION 26-04-16-59**

**WHEREAS**, the Board of Fire Commissioners of Hanover Township Fire District No. 3 is responsible for providing fire protection and emergency medical services within the District; and

**WHEREAS**, the Township of East Hanover provides emergency medical services and public safety operations within its jurisdiction; and

**WHEREAS**, both parties recognize the operational benefit of entering into a Shared Services / Mutual Aid Agreement to allow for the temporary loan of emergency vehicles and the provision of reciprocal Basic Life Support (BLS) ambulance services, when available; and

**WHEREAS**, such an agreement will enhance the ability of both agencies to maintain continuity of service during emergencies, equipment outages, or other operational needs; and

**WHEREAS**, the Board has reviewed the proposed Agreement and finds it to be in the best interest of the Fire District No. 3 and the residents it serves.

**NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY** as follows:

1. The Chairman of the Board of Fire Commissioners, or his/her designee is authorized to sign and execute the attached Memorandum of Agreement, between Fire District No. 3 and the East Hanover Fire Department.


