## RESOLUTION AUTHORIZING THE PURCHASE OF COMMAND VEHICLE

### RESOLUTION 26-04-16-60

**WHEREAS**, the Board of Fire Commissioners of Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, has determined a need for the purchase of a Chief's vehicle to support fire department operations and command staff response; and

**WHEREAS**, said vehicle shall be a 2026 Chevrolet Tahoe (CK10706) 4WD 4dr, as specified in the vendor quotation; and

**WHEREAS**, the vehicle may be procured through Nielsen Fleet, 31 Williams Parkway, East Hanover, New Jersey, pursuant to MCCPC Co-Op Contract #15-A, Item #7; and

**WHEREAS**, the total cost of said vehicle, including all options, is \$62,288.02; and

**WHEREAS**, funds for this purchase were duly appropriated in the District's 2026 Capital Budget in the amount of \$65,000.00; and

**WHEREAS**, the District Treasurer has certified that sufficient funds are available for this purpose; and

**WHEREAS**, public bidding is not required as the purchase is being made through a cooperative purchasing agreement in accordance with N.J.S.A. 40A:11-12 of the Local Public Contracts Law;

**NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY as follows:**

1. The purchase of a 2026 Chevrolet Tahoe (CK10706) 4WD 4dr from Nielsen Fleet under MCCPC Co-Op Contract #15-A, Item #7 is hereby authorized, provided that the total cost shall not exceed \$65,000.00;
2. The appropriate District No. 3 officials are hereby authorized to execute all necessary documents, including the issuance of a purchase order, to effectuate this purchase;
3. This Resolution shall take effect immediately.
4. It is hereby certified that this resolution is adopted by the Board of Fire Commissioners on this the 16<sup>th</sup> day of April, 2026
