WHEREAS, the total of such temporary appropriations, pursuant to N.J.S.A. 40A:14-78.17 shall not exceed 14% of the total of the 2009 annual budget, less certain appropriations.

NOW, THEREFORE, BE IT RESOLVED by the Fire Commissioners of the Township of Hanover Fire District No. 3 that the following shall constitute the Temporary Budget for the Township of Hanover Fire District No. 3 for the fiscal year 2010.



ADOPTED BUDGET RESOLUTION

FISCAL YEAR: From January 1, 2010 to December 31, 2010

WHEREAS, the Annual Budget for the Township of Hanover Fire District No. 3 for the fiscal year beginning January 1, 2010 and ending December 31, 2010 has been presented for adoption before the Board of Commissioners of the Township of Hanover Fire District No. 3 at its open public meeting of December 17, 2009; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and


WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$1,041,622, which includes amount to be raised by taxation of \$839,550 and Total Appropriations of \$1,041,622 ; and

WHEREAS, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount of money to be raised by taxation for the ensuing year.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Township of Hanover Fire District No. 3, at an open public meeting held on January 21, 2010, that the Annual Budget of the Township of Hanover Fire District No. 3 for the fiscal year beginning January 1, 2010 and ending December 31, 2010 is hereby adopted and shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$1,041,622, which includes amount to be raised by taxation of \$839,550, and Total Appropriations of \$1,041,622 ; and

BE IT FURTHER RESOLVED, that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

BE IT FURTHER RESOLVED, that an annual election shall be held on the third Saturday of February to determine the amount of money to be raised by taxation for the ensuing year. The results of which shall be subsequently certified to the Division and the Municipal Assessor.


