WHEREAS, the Fire District intends to utilize the online auction services of GovDeals, Inc. 5907 Carmichael Place, Montgomery, AL 36117; and


WHEREAS, the sales are being conducted pursuant to the Division of Local Government Services' Local Finance Notice 2008-9,


